



FORESHORE CLUB PARKING PERMIT APPLICATION

WHO IS ELIGIBLE FOR A FORESHORE CLUB PARKING PERMIT?

Members of approved foreshore clubs/associations are eligible to apply for a Foreshore Club Parking Permit.

WHAT DOES A FORESHORE CLUB PARKING PERMIT EXEMPT ME FROM?

A Foreshore Club Parking Permit exempts the holder from paying the relevant fee at all paid parking locations along the back road (foreshore) and in the public car parks located on the beach side of the foreshore. All time restrictions must be adhered to.

Specific areas of coverage include:

Port Melbourne – Beach Street, Beach Street Car Park, Station Pier Car Park, Waterfront Place

St Kilda – Jacka Boulevard, Beaconsfield Parade, Marine Parade, Marine Parade Car Park, Pier Road

Middle Park / Albert Park – Beaconsfield Parade

Elwood – Point Ormond Car Park, Elwood Car Park, Point Ormond Road

FORESHORE CLUB PARKING PERMITS DO NOT EXEMPT ME FROM:

Foreshore Club Parking Permits DO NOT exempt the holder from:

- Over-staying any time limits displayed on parking signs
- Parking bays that do not require a fee
- Shakespeare Grove car park
- Neighbouring municipalities (please check with Council if unsure where our boundaries lie)
