APPLICATION TO PARTICIPATE

INSURANCE

- Membership of Windsurfing Victoria Inc, and other associations affiliated with the Australian Windsurfing Association, includes this insurance

- You also understand that AWA insurance does not cover injury to you or your equipment. The Organisers strongly advise you to have personal accident & health insurance for the Event

LIFE JACKET

You must wear an approved PFD for the water board and race location the event is being held. The PFD must be worn during the Event whenever required to do so by law.

YOUR FITNESS TO RACE

- You have sole responsibility for your decisions to enter, start and continue in the Event
- You represent that your windsurfing skills are sufficient to allow you to participate safely in the Event
- You represent that you have no medical or other condition that may increase the risks to you or others if you participate in the Event
- You represent that you will not participate in the Event under the influence of alcohol or any mind-altering substance

RELEASE & INDEMNITY

- You understand that windsurfing can be inherently dangerous, and accept all risks to you and others of injury, death, and property damage involved in the Event
- You agree that the Organisers are not liable for any injury, loss or damage suffered by you or any other person relating to this Event:
 - regardless of any negligence on the part of the Organisers; and
 - to the full extent permitted by law
- In consideration of the Organisers accepting your entry, and to the full extent permitted by law:
 - you release the Organisers from any Claim; and
 - you indemnify the Organisers in relation to any Claim by any person, relating to your participation in the Event

RACE DIRECTIONS

You must comply with all Event rules, and all directions given by the Organisers concerning the Event (including a direction to cease your participation).

MEDICAL TREATMENT
